DIRECT CLIENT SERVICES - WHEN PEOPLE ON CALIFORNIA'S RURAL NORTH COAST FACE BREAST OR GYNECOLOGIC CANCER CONCERNS, THEY HAVE TURNED TO THE BREAST & GYN HEALTH PROJECT FOR FREE CANCER RESOURCE CENTER SUPPORT SERVICES SINCE 1997. IN 2020, DESPITE THE PANDEMIC, 327 CLIENTS RECEIVED OVER 6,900 SERVICES FROM THE COMPASSIONATE STAFF AND VOLUNTEERS, MANY OF WHOM ARE CANCER SURVIVORS THEMSELVES. ALTHOUGH MEDICAL SERVICES ARE NOT PROVIDED, UP-TO-DATE, HIGH QUALITY INFORMATION IS A KEY SERVICE PROVIDED. DURING THE PANDEMIC CLIENTS ARE ABLE TO ATTEND OUR SEVEN DIFFERENT SUPPORT GROUPS VIA ZOOM. GRASSROOTS SUPPORT FROM DONORS, VOLUNTEERS AND GRANT FUNDERS KEEP THE DIVERSE SERVICES AVAILABLE FOR ALL.
